CAPACITY, ACCOUNTABILITY & PROVISION FOR THE EXCEPTIONAL STUDENT

Boards of Governors and their advisers wrestle with the controversial relationship between what the school can provide or should provide for whatever number of exceptional students the school enrols. Capacity and costs compete with ideals, responsibilities and opportunity. Also the important issue of maintaining a balance within each enrolment cohort (however defined), has to be considered. So, how might enrolment limits for exceptional students be established without offending the spirit of discrimination legislation? Also, can a match be negotiated between parental expectations and the school's capacity to provide at enrolment upon a contract being entered upon? How should the Registrar establish a formal agreement at the point of enrolment that will emphasise opportunity but limit accountability?
